Media Participation

Complimentary meeting registration is available to members of the media who provide appropriate press credentials and identification via the conference registration system. All scientific sessions at The EMBO Meeting 2016 are open to registered members of the media. Registered journalists must wear/display their conference press badge at all times while onsite. Exchanging, loaning or borrowing of the conference press badge is not allowed. Filming onsite during the conference must be pre-arranged with the EMBO Communications office. Abstract / Poster submission is only open to registered scientific attendees - media registrants are not entitled to present posters. Complimentary media registration is not available to: advertising, marketing, public relations or sales representatives from any publication; publishers; editors; in-house newsletters or promotional publications staff; public relations representatives of exhibitors or educational institutions; writers of commercial reports and financial analysts; medical education companies; or others who are not reporting on the content of The EMBO Meeting 2016.

Legal Conditions

Organizer of *The EMBO Meeting* is *Gesellschaft zur Förderung der Lebenswissenschaften Heidelberg GmbH* (VAT Nr. DE264471047). The scientific programme is the organizer's responsibility. MCI Deutschland GmbH is acting as an agent for hotel accommodation and social programme. Registration fees are collected by MCI Deutschland GmbH on behalf of the organizer.

These general terms and conditions and all subsequent information are to be considered as the legal basis for all reservations.

Verbal agreements are not binding, unless confirmed in writing. All vouchers/documents will only be distributed upon receipt of full payment. Please pay any balance on time, as indicated on your invoice. There will be no refund or replacement for lost or unused vouchers/ documents. If the badge is lost or forgotten, a replacement badge will be issued at a charge of € 10.-. Should the badge be mislaid a second time, the individual would need to re-register onsite at the published rates.

The participant acknowledges that he/she has no right to lodge damage claims against the organizer should the meeting or parts hereof be hindered or prevented by unexpected political or economic events or generally by force majeure, or should the last-minute cancellation of speakers or other reasons necessitate programme changes.

Act of God / Force Majeure

It is mutually agreed that in the event of total or partial cancellation of the congress due to fire, strike, natural disaster (either threatened or actual), government regulations or incidents not caused by the organizer, which would prevent its

scheduled opening or continuance, this agreement may be partially postponed or terminated as a whole. In this case, participants are not entitled to reclaim refunds on no account. Participants are obliged to have a civil liability insurance.

In the case of cancellation, a timely shift or changes in the duration of the event, the registration remains its validity. However, in this case a cancellation is possible with prior written consent of the organizer. Where justified, 25% of the invoice amount will be due as a general measure of compensation for costs occurred, payable by the applicant to the organizer.

The proof of the non-occurrence of a loss damage or lower losses occurred, expressly remains within the responsibility of the applicant.
